Mayor Davis called the meeting to order at 6:00 p.m. Alderman Steele led the invocation and pledge of allegiance.

Approval of the Agenda: Alderman Driggers made a motion to amend the agenda to add Caddo Parish Sheriff Office Lt. Douglas, the motion was seconded by Alderman Clemons and was carried by unanimous voice vote.
